SPONSORSHIP TERMS & CONDITIONS

Sponsorship Assignment Criteria

WLT Industry Partner exhibiting sponsorship opportunities will be made available by invitation only on a first-come, first-serve basis with the first right of refusal given to the previous sponsor of said opportunity. All exhibiting sponsors must be an actively contracted WLT Industry Partner, in good standing with WLT Software and WLT Clients in general. WLT Software reserves the right to review any exhibiting sponsorship for appropriateness for our Client audience and support of WLT's business goals.

Once an exhibiting sponsorship invitation is provided to the WLT Industry Partner, the exhibiting sponsorship form must be completed and submitted within 45-days of invitation. WLT Software requires that all exhibiting sponsorships be paid in FULL at least 60 business days prior to the start of each conference. Listing of exhibiting sponsors in event promotions will not occur until payment is received. Note - If payment is not received when due, WLT Software reserves the right to re-assign the opportunity.

Hospitality Suites: All hospitality suites must be approved and arranged through WLT Software in advance.

Off-Site Events: In the interest of the success of the entire WLT Client Conference and exposition, the WLT Industry Partner agrees not to extend invitations, call meetings, or otherwise encourage the absence of WLT Client attendees from scheduled conference functions (which are detailed in the WLT Client Conference Agenda).
